- 5. Residents of the parish of Brooke who have lived in that parish for less than 3 years
- 6. Residents of the adjacent parishes of Woodton, Shotesham, Howe, Alpington, Bergh Apton and Kirstead who have lived in those parishes (or the parish of Brooke) for less than 3 years
- 7. Residents of South Norfolk
- 8. Any other person

3 Homes for Rent

1 two bedroom house

They will need to provide proof of their residency or working qualification criteria as well as other verification details. During the week that the properties are advertised on the HomeOptions system people will need to actively apply '(bid') for them, and the Council's Housing Officers will be able to provide details of how to do this.
