The agreement of the 24 October is with the Parish Council. However, anyone is entailed to comment on a planning application throughout the process until a decision is issued. To ensure that comments made are contained within my DMC written report, however, they should be submitted two weeks prior to the Development Management Committee meeting and if necessary any late comments can be given as a verbal update to members at Committee. As it stands at the moment we are aiming for the DMC meeting on 7 November, so 24 October would be two weeks before.
Notwithstanding the above, I would encourage any comments to be made well before this date if possible.
As you are probably aware that we have yet to receive the Viability Report, once this is submitted I will formally reconsult all consultees, neighbours etc. again for a period of 21 days, to enable further comments to be made.
On the website, once the 'neighbour consultation' period expires (7 September), it does not allow any further comments to be submitted via our site (comments made by emails to planning@s-norfolk.gov.uk, myself and posted letters are not effected) therefore to be helpful I have extended the 'neighbour consultation' period on the website until the 27 September , to enable comments to be still be submitted.
